Drivers License #:		Exp:	Any person may join the KDDA as a driver, you are a voting member. You will not be eligible to drive in a pitman event for 5 years from your last paid driver's membership. You must be 16yo to be an active driver. A pitman must be 14yo to participate. If under 18yo a parental waiver must be completed at each event prior to getting a pit pass. Special Memberships include Board Members (President, Vice President, Business Agent, Secretary, Treasurer), Honorary, and Lifetime Members. Special Members do not pay for yearly membership but must pay for pit passes at the gate on race day. Visiting members may participate in ONE KDDA event per season paying a \$35 membership fee. Visiting drivers must complete a membership agreement. Car numbers will be held for returning drivers until the adjournment of the March general meeting. At that time, the number will be released and available to new and renewing members. Numbers may be frozen with a club vote.

Any member or official who, in the opinion of the board is found guilty of unsportsmanlike conduct or conduct detrimental to the organization will be suspended for a period of not more than one year. Driver members are responsible for all actions made by his/her pit crew that violate any of the club's rules and regulations. Constant violation of club rules by the same pit crew are grounds for an inquiry by club officials with the possibility of disciplinary action being taken against the driver member. These actions could include warnings, fines, expulsion of the pits, revocation as a pitman. The driver may also face suspension and loss of pay/points.
